Important Rules and Regulations forming art of enrollment conditions

1. FB TRAINING CENTER is open to all students and provides equal opportunities, but reserves the right of admission on grounds of academic performance and good behavior. **ALL** students **MUST** conduct themselves professionally whilst in FB TRAINING CENTER's premises. Students behaving offensively with **FB TRAINING CENTER** staff will have their studentship instantly terminated without recourse. FB TRAINING CENTER reserves the right to decline admission to any student without the need for any reasons, explanations or justification. **All students will abide by the FB TRAINING CENTER Dress Code and will refrain from dressing in a revealing indecent manner.**
2. FB TRAINING CENTER **SHALL NOT** be responsible for any loss or damage caused to the student's property. Students are required to take care of their property personally. FB TRAINING CENTER's property (Equipment, Furniture, etc) **MUST** be used with proper care. Students **WILL BE LIABLE TO PAY** the replacement value for damage to any property of the Center. 3. Disruption of lectures by either reporting late or leaving early amounts to **MISCONDUCT** and students will be reprimanded severely and have their classes discontinued. All Mobile phones should be **SWITCHED OFF** during lecture hours. Students must read the relevant notices in the classrooms.

FB TRAINING CENTER **WILL NOT BE RESPONSIBLE** for any consequences arising out of delay / non-payment of the registration / examination and annual subscription fees to the respective association by the students. All students sending their registration and examination fees are requested to bring their completed forms and bank pay in slips to the FB TRAINING CENTER office by the dates indicated on the notice board.
